I attended the following meetings this month: Chester County Zone, Ad Hoc Website, Finance, Office Staff, and Steering Committees. I chaired the Special Events Committee meeting held on April 27th. See pages 7 and 8 for the minutes from this meeting.

The Virtual Round-Up was held on the weekend of April 17-19th via Zoom. Attendance was good: 315 participants for the Friday night A.A./Al-anon Speaker Meeting, 410 for the Long-timers Panel on Saturday afternoon, 374 for the Saturday night Banquet Speaker Meeting and 303 for the "God as I Understand Him" meeting on Sunday morning. Some time for general sharing happened after each meeting. Fred S. provided welcome entertainment during the run-up to the meetings.

The Round-Up in Cape May has always been the largest funding raising event in past years. Many members have donated their registration fee to SEPIA after the cancellation. The office reported a large increase in contributions during the Virtual Round-Up. Orders are still being taken for "Miracles by the Sea" tee-shirts and hoodies. Due to the lock-down, the shirt/hoodie order has been delayed. We will make an announcement when the order is processed by the vendor. Arrangements will be made to provide delivery of these items. Thanks for your patience. I would like to thank all the committee members, participants and hosts who made the Virtual Round-Up possible. Credit must be given to Dan S. who suggested this during the March Special Events Committee meeting.

Special Events Committee Report from Monday, April 27, 2020

Rich opened the meeting at 7pm and recited the Serenity Prayer.
Roll call (Rich has the list of attendees)

VIRTUAL ROUND-UP COMMENTS:

- Rich thanked everyone who worked on it behind the scenes and participated.
- Maria: great speakers, received a lot of positive feedback
- Mark: he got great feedback as well. Suggested a zoom mtg for the next R/U so more people can attend.
- Rich: people who could not afford it were able to attend online
- Elaine: suggested Zooming the Saturday night speaker mtg. people wished they could have taped the main speakers.
- Rachel: Asked how did we do financially?
- Rich: Sold 216 items– 600 ordered initially. Zip-ups and hoodies are selling well, t-shirts not selling as well.
- Elaine: From Registration Fees: \$4,300 refunded to people, \$7,800 were donated.
- Rich: The office is still trying to obtain responses from people who signed up for the registration and banquet to see if they want to donate the money.
- Janet: You can detail on Venmo if you want the donation to be allocated to the R/U or other.
- Rich: We will not make nearly as much money as in the past from the R/U.

Refund Status:

- The entire original t-shirt, hoodie order will be cancelled. We will then place a reduced order based on our current and expected sales. (\$4,600 in sales received to date.)
- The pin order cannot be cancelled. We ordered 1,400 pins and the cost was \$1,000. Possibly give them out to the people who order hoodies/t-shirts.
- DJ will be reimbursing the full \$2,000 submitted to him. We'll be receiving the return payment in installments.
- Ice cream order was cancelled. (no penalty mentioned).
- This year's deposit at the Grand Hotel was rolled over to next year (April 16-18, 2021).

GRATITUDE BREAKFAST:

- Rich is going to get available dates in October 2020.
- Fred: Referenced other activities that fall in late Sep/ early October may be a good time to acknowledge the incoming and outgoing committee members
- Bebe: suggested having 2 meal events to raise money.
- Timsky: have a virtual event ready to go in case the virus flares back up in the fall.
- Greg, Elaine: both expressed concern that social distancing may still be an issue in the fall.
- We should explore more ideas of other possible types of events or virtual events at our next meeting.
- Next mtg on Monday, May 18 via Zoom- not at the office.
- Timsky- expressed concern that he had been sharing too much this meeting.
- Multiple people suggested virtual fund raisers.
- Noreen: Googled virtual fund raisers, believes this may provide some good ideas to share next month.
- Fred: suggested a talent show.

- It has been announced at Intergroup Meetings and told to people who have called into the office that they will be advised of a new date; it will likely be rescheduled for a date in the fall. If the participant cannot make the new date, they will be given the option of reimbursement if the new date doesn't work for them.

Treatments Committee has been meeting on a weekly basis since the last week in March.

Below is our report:

Open each weekly meeting with Serenity Prayer

- online meetings were launched for facilities on April 13th.
- meetings through TFC are strictly for the facilities, the meeting info is not being shared with anyone other than the facilities and those chairing/hosting.
- each county facilitates 2-3 meetings per week.
- each liaison and assistant liaison from each county are continuously reaching out to facilities to get the meeting information to the directors/counselors.
- meeting attendance by facilities is low; we are finding that many facilities are holding their own meetings and asking for outside speakers.
- we are providing all IGRs and general members the opportunity to be in service as chairs/speakers
- we have set security measures as strictly and appropriately as possible to ensure that we are protecting HIPPA laws and anonymity.
- Currently we are holding 12 meetings a week on the following schedule:

 TUESDAY'S- 7PM & 8PM CO-ED
 WEDNESDAY'S- 7PM & 8PM CO-ED
 THURSDAY'S- 7PM CO-ED

 SATURDAY'S- 7PM (CO-ED) & 8PM (MEN'S ONLY)
 SUNDAY'S- 11AM (WOMEN ONLY) & 7PM (CO-ED)

Website

Suspended vs. online meetings. Some meetings are still in person and people are calling the office staff adamant about attending face-to-face meetings. What is SEPIA's position on this? We support the groups; we don't govern the groups.

We will place classifying neighborhoods on indefinite hold. Now we pivot to PayPal, Venmo, and online meeting platforms. We will also table Abby's action items from the last meeting.

Brandon said the committee is doing an excellent job adjusting so rapidly to the changes.

Sam and Brandon will meet on Friday afternoon about the literature website. Shipping is still happening. Sam needs help with analytics on the store. We want a single inventory system - Zen Cart that can synch with Quickbooks. There are issues with Stamps.com. We should be using them to create the label automatically. Sam adjusted the handling fee down a bit and adjusted the weight preset.

Get the Round-Up flyer on the website. Elaine is working on sending out emails with a pdf of the Round-Up to get the word out. How to pick-up merchandise for the Round-Up? Once restrictions are lifted, volunteers will deliver the items, or they can be picked up from the SEPIA office.

New Business

Venmo account for SEPIA? It is set up for now on Elaine's mobile phone. Kevin suggested the Treasurer's phone should be linked to Venmo. Sam suggested getting a burner phone to keep in the safe and link to PNC. Scott feels the office staff should be able to manage the Venmo. Maria agreed that the Venmo and money should be kept in the office (rather than with the Treasurer). Venmo is the same as PayPal, 2.9% plus \$0.30 per transaction.

Maria feels the Office Manager should have a mobile phone. She uses her personal phone a lot for SEPIA business.
