## Treasurer's/Finance Committee Report from Thursday, September 15, 2022

- Meeting opened with Serenity Prayer at 7:06 pm; Attendance: Jim B. (Interim Treasurer), Stephanie W. (Interim Asst Treasurer), Donna S. (Mont Co liaison), Erik (Bucks liaison), Steve S (Asst director PI), Fran G. (Office Manager), Kevin B., Elaine J. and Sam H. (members)
- Open with Serenity Prayer
- Read and discussed Tradition 11 and Concept 11
- Reviewed Financial Reports: Monthly Income Statement (P&L), Year-to-Date Income Statement, Balance Sheet
  - August 2022 Income Statement (P&L): Comparing to budget, please note many expenses are estimated as annual costs and pro-rated equally over 12 months rather than in the months normally incurred.
     Additional discussion:
    - QuickBooks changes should be coming in October. New accounts are being added as a need is identified and after incorporating the consultants' other changes, renaming and shifting of accounts will be updated.
    - Individual contributions are lower than budget and literature sales are higher than budget.
    - Cost of goods sold appears way out of line with income. This may be difficult to understand in the short term, month over month, but it will be getting better as we continue to make changes and identify inconsistencies.
  - Year-To-Date (Nov August) Income Statement:
    - Discussion regarding interest income and if we can obtain a higher interest rate at a different banking institution and/or invested in different types of accounts. To be explored further as we determine appropriate amount of assets to leave liquid.
    - Discussion regarding margins/discounted prices and shipping costs on inventory ordered from AAWS and Grapevine. To continue to be analyzed and improve accuracy and breakout of costs where appropriate.
    - Committee expenses are coming together and are being recorded as accurately as possible each month.
    - Computer/fax equipment, website hosting fees and Employee Benefits fees are higher than forecast. Computer equipment includes new computers. Website fees include a full year of zoom costs in FYE 2022. Payroll entries need to be grossed up to reclassify benefits as compensation.
    - Discussion on classifying expenses indirectly related to the office move. New account to be added for office improvements separate from office supplies.
  - Balance Sheet: Accounting processes need to be re-vamped to clean up anomalies (offset accounts),
     which will happen with QB consultant. Additional discussion:
    - Open question regarding capitalization of recent computer purchases (should they be posted as general office expense or entered as a capital investment). Fran to discuss with accountants.
    - Open question regarding accuracy of inventory availability in QuickBooks/Zencart to ensure accuracy and proper costing. Ongoing conversations with Delmarva consultants.
    - PNC credit card line item is inaccurate. Internal misposting as these should have been posted to the PNC bank account. To be corrected next month.

#### Office Manager Report

- QuickBooks consultant has a copy of our books and is working through items. Hopefully the file will be returned in October for us to incorporate changes.
- Looking for new hire in the office.
- Suggested passing on merchant service charges/fees to the persons ordering literature so SEPIA does not have to incur the excess expense. Other Intergroups are doing this without incurring significant challenges
- Mentioned the high cost of phones/hot line from Comcast. Sam to work on advantages/disadvantages
  of alternative providers

- Open Discussion:
  - Visitation to committees to discuss remaining budgets for this year and developing budgets for FYE
     2023. Treasurer/Asst Treasurer/Office to help with obtaining reports of amounts spent in previous years. Discussion of progress made so far by members.
  - QuickBooks store integration Looking at alternative options to bridge ZenCart to QB. Tool needs to be properly supported. This is critical to accurate inventory figures and costing, which is a major part of our financials.
  - Overall FYE 2023 budget discussion to be discussed offline.
  - Ongoing need for standardization of processes and training of employees.
  - Store will be shut down at end of October 2022 to allow for proper inventory to be taken at the office.

Their administration must account for every minute of work they assign and can lose their accreditation if they exceed certain time restrictions. This also applies to our pre and post meeting. Meet no more than 20 minutes before.

- Members continued to explore methods to support the five-county outreach to inmates.
- All zone liaisons present gave their reports.
- Participation in the Temporary Pen Pal Project is ongoing and we are grateful to prison committee members and zone liaisons for their outreach.
- Grapevine articles continue to be mailed to various facilities for inmates and Big Books, old Grapevines and other AA literature were forwarded upon request. Requests for Spanish literature will be forwarded.
- Communication is ongoing between AA and facilities on any change in status to re-opening or return to meetings.
  - o Bucks County continues to bring 3 online men's meetings and one women's meeting weekly.
  - o Delaware and Montgomery Counties have no updates or change in status to report.

- Temporary contact forms provide the information of another alcoholic that can be there when someone is released from prison to escort the individual to a meeting, get them connected with other members, provide them with phone lists, etc. it is our responsibility to carry the message to next sick and suffering alcoholic.
- SCI Chester currently has 3 meetings a week. The prison is looking for Spanish speaking volunteers.

Get the phone number of whoever in your HG takes the commitment, add the date to your calendar, and check with the person periodically leading up to the commitment's date. If no one in your HG is able to fill the commitment, go outside of your HG and try to get it filled. If you absolutely cannot find anyone, then reach out to Dylan as soon as possible. Unless absolutely necessary, do not wait until the day of to let treatment know that the commitment cannot be filled. The more notice, the better.

- Taking an H&I commitment typically requires 2 people, a chairperson and a speaker
  - o 1 year of sobriety is preferred for speakers, but an active 90 days is usually acceptable
  - It is important that we conduct ourselves appropriately when visiting hospitals and institutions, as we are representing AA as a whole.
